

Listed company that fails to submit information and report under section 56

Under the Securities and Exchange Act B.E. 2535 (1992), the Stock Exchange of Thailand (SET) requires all listed companies to submit their financial statements, report on the disclosure of additional information (Form 56-1) and Annual Reports (Form 56-2) within given deadlines.

However, as of September 30, 2016, twelve listed companies still have not submitted the required documents within the deadlines. Investors and other interested parties are hereby advised accordingly.
